TIMET EXTENDS LABOR CONTRACT TWO MONTHS

DENVER, COLORADO . . . August 26, 2004 . . . Titanium Metals Corporation (TIMET) (NYSE: TIE) announced that it has entered into a two-month extension of the collective bargaining agreement covering the hourly production and maintenance workforce at its titanium sponge and melting facility in Henderson, Nevada. That group of approximately 300 employees is represented by the United Steelworkers of America (Local 4856). The agreement, entered into at the request of the USWA to address scheduling conflicts, extends the existing labor contract that was due to expire on October 2, 2004, through December 10, 2004.
