The award on January 23, 2008, was actually issued as 3,076 phantom stock units in the Directors' Deferred Compensation Plan reported in Table II. This amended report corrects the issuance information.

(5) On October 2, 2007, the common stock of Johnson Controls Inc., split 3-for-1, resulting in the reporting person's ownership of 27,655.04 of additional phantom stock units.
