J Carlo Cannell is the controlling and managing member of Adviser. Adviser serves as investment adviser to Cuttyhunk, Anegada Master, GSC, and Pleiades. Adviser is general partner and investment adviser to Tonga.

Item 3 Source and amount of Funds or other Consideration

The aggregate amount of funds used by Cuttyhunk to purchase 420,100 shares of Common Stock owned by it was approximately \$3,540,499. Such amount was derived from working capital.

The aggregate amount of funds used by Anegada to purchase 324,485 shares of Common Stock owned by it was approximately \$2,824,493. Such amount was derived from working capital.

The aggregate amount of funds used by GSC to purchase 157,200 shares of Common Stock owned by it was approximately \$1,322,455. Such amount was derived from working capital.

The aggregate amount of funds used by Tonga to purchase 631,600 shares of Common Stock owned by it was approximately \$5,315,576. Such amount was derived from working capital.

The aggregate amount of funds used by Pleiades to purchase 87,200 shares of Common Stock owned by it was approximately \$734,829. Such amount was derived from working capital.

Item 4 Purpose of Transaction

The Common Stock was bought in the ordinary course of the Adviser's management of the accounts of its investment advisory clients. As of April 30, 2004 the Reporting Persons commenced the formulation of plans to seek maximization of the value of the Common Stock. Such plans may include, but may not necessarily be limited to, pursuit of strategic initiatives to enhance shareholder value.

Subject to availability at prices deemed favorable and in accordance with applicable laws and regulations, the Reporting Persons may acquire shares of Common Stock of the Company from time to time in the open market, in privately negotiated transactions or otherwise. The Reporting Persons may dispose of shares of Common Stock of the Company from time to time in the open market, in privately negotiated transactions or otherwise.

Except as set forth above, the Reporting Persons has no present plans or intentions that relate to or that would result in any of the transactions described in clauses (a) through (j) of item 4 of Schedule 13D.
