**ITEM 1. SECURITY AND ISSUER.**

The class of equity securities to which this Schedule 13D Statement relates is shares of common stock, par value \$0.001 per share, of Doral Energy Corp., a Nevada corporation (the Company ). The principal executive offices of the Company are located at 111 N. Sepulveda Blvd., Suite 250, Manhattan Beach, CA 90266.

**ITEM 2. IDENTITY AND BACKGROUND**

A. Name of Person filing this Statement:

**EVERETT WILLARD GARY II** (the Reporting Person )

B. Residence or Business Address:

The business address of the Reporting Person is 2002 Bedford Midland, Texas 79701.

C. Present Principal Occupation and Employment:

The Reporting Person is currently employed as a sales representative at a Fortune 100 company.

D. The Reporting Person has not been convicted in any criminal proceeding (excluding traffic violations or similar misdemeanors) during the last five years.

E. The Reporting Person has not been a party to any civil proceeding of a judicial or administrative body of competent jurisdiction where, as a result of such proceeding, there was or is a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

F. Citizenship: The Reporting Person is a citizen of the United States of America.

**ITEM 3. SOURCE AND AMOUNT OF FUNDS OR OTHER CONSIDERATION.**

On July 23, 2008, pursuant to the terms of a Share Transfer Agreement (the Share Transfer Agreement ) between the Paul Kirkitelos, the sole executive officer and director of the Company, and WS Oil & Gas Limited, a Texas limited partnership controlled by the Reporting Person, WS Oil & Gas Limited purchased 9,700,000 shares of the Company s common stock (the Shares ) from Paul Kirkitelos. In consideration of the Shares, WS Oil & Gas Limited paid \$41,419 to Dr. Kirkitelos.

**ITEM 4. PURPOSE OF TRANSACTION**

The Reporting Person acquired the Shares held by Dr. Kirkitelos for investment purposes. As a result of the completion of the sale of the Shares to the Reporting Person, the Reporting Person now owns approximately 9.1% of the outstanding shares of the Company s common stock.

As of the date hereof, except as otherwise disclosed above, the Reporting Person does not have any plans or proposals which relate to or would result in:

(a) the acquisition by any person of additional securities of the Company, or the disposition of securities of the Company;

- (b) an extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the Company or any of its subsidiaries;
- (c) a sale or transfer of a material amount of assets of the Company or any of its subsidiaries;

- (d) any change in the present board of directors or management of the Company including any plans or proposals to change the number of term of directors or to fill any existing vacancies on the board;
- (e) any material change in the present capitalization or dividend policy of the Company;
- (f) any other material change in the Company's business or corporate structure;
- (g) changes in the Company's Articles of Incorporation or other actions which may impede the acquisition of control of the Company by any person;
- (h) causing a class of securities of the Company to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;
- (i) a class of equity securities of the Company becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Act; or
- (j) any action similar to any of those enumerated above.
