Passport Global Master Fund SPC Ltd for and on behalf of Portfolio A Global Strategy (the Fund); Passport Capital, LLC (Passport Capital); and John H Burbank III (Burbank, together with the Fund and Passport Capital, the Reporting Persons).

Burbank is the sole managing member of Passport Capital; Passport Capital is the investment manager to the Fund. Passport Capital is also the investment manager to certain other funds and accounts (the Other Accounts) that are the owners of record of an aggregate of 1,065,261 Shares. None of the Other Accounts individually own (beneficially or of record) more than 5% of a class of the Issuer's equity securities that are registered under Section 12 of the Securities Exchange Act of 1934, as amended. Under the terms of the relevant investment management agreements, Passport Capital generally has the right to dispose of, and in most cases vote, the Shares owned of record by the Fund and the Other Accounts. As a result, each of Passport Capital and Burbank may be considered to share the power to vote or direct the vote of, and the power to dispose or direct the disposition of, the Shares owned of record by the Fund and the Other Accounts, except in the case of certain Other Accounts which maintain sole power to vote or direct the vote of their beneficially owned shares. This statement on Schedule 13G shall not be construed as an admission that any of the Reporting Persons (other than the Fund) is the beneficial owner of the securities covered by this statement.
