On August 7, 2013, announces that the Company has been notified by the vendor of the Pennsylvania oil property, that three oil wells have been successfully brought on production and are currently unloading frac water with oil starting to flow. The fourth well is currently being fracked and will be tied in to the production facilities shortly. The Company has no direct interest in these wells, but does have an option to participate in up to 100 light oil wells on the same lands.
