The Company has rescheduled the date of its annual meeting of stockholders to February 13, 2008. The new record date for the annual meeting is January 7, 2008. This is a rescheduling of the annual meeting previously proposed to be held on December 14, 2007 with a record date of October 31, 2007. The Company's proxy materials regarding its annual meeting filed with the Securities and Exchange Commission on November 6, 2007 will be revised accordingly. The date of the annual meeting constitutes a change of more than 30 days from the anniversary of last year s annual meeting. As a result, in accordance with Rule 14a-8 under the Exchange Act, as amended, the Company has set a new deadline for submitting stockholder proposals for inclusion in the annual meeting and related proxy materials and for submitting proposals for presentation at the annual meeting. The new deadline is December 28, 2007. The Company did not receive any stockholder proposals in connection with this year s annual meeting by August 31, 2007.

The submission of a stockholder proposal does not guarantee that it will be included in the Company s proxy statement. Proposals for inclusion in our proxy statement or for presentation at the annual meeting must be submitted to us in writing at c/o Media Sciences International, Inc., 8 Allerman Road, Oakland, New Jersey 07436, Attention: Secretary. There are additional requirements regarding proposals of stockholders, and a stockholder contemplating submission of a proposal is referred to Rule 14a-8 promulgated under the Securities Exchange Act of 1934.
