MOSCOW, RUSSIAN FEDERATION JULY 13, 2007 MOBILE TELESYSTEMS OJSC (MTS - NYSE: MBT), THE LARGEST MOBILE PHONE OPERATOR IN RUSSIA AND THE CIS, ANNOUNCES THAT ITS CONSOLIDATED SUBSCRIBER BASE REACHED 74.67 MILLION USERS ON JUNE 30, 2007.

During June 2007, MTS consolidated subscriber base in Russia increased by 0.53 million subscribers.
