On August 9, 2007, Christopher & Banks Corporation (the Company) issued a press release disclosing material nonpublic information regarding the Company's sales results for the five-week and twenty-two week periods ended August 4, 2007. In the press release, the Company also announced that it continues to anticipate a low single digit increase in its fiscal second quarter same-store sales and expects its earnings for the second quarter to track at or near the low end of its previously stated guidance of \$0.11 to \$0.12 per diluted share.
