Pursuant to the Company s 2006 Incentive Stock Plan, effective as of the date that Mr. Hawkins commences service on the Board, he will be granted that number of restricted stock units for shares of Company Common Stock number of shares of Company Common Stock (Common Stock) calculated by dividing \$250,000 by the per share closing price of the Common Stock on the date of grant, which units will vest in four equal installments on the first four anniversaries of their grant date. Mr. Hawkins will also receive the standard Board member annual retainer fee of \$40,000.
