Item 8.01. Other Events.

On September 20, 2012, Hovnanian Enterprises, Inc. (the Company) announced that its wholly-owned subsidiary, K. Hovnanian Enterprises, Inc. (K. Hovnanian), priced \$577.0 million aggregate principal amount of 7.250% senior secured first lien notes due 2020 (the First Lien Notes) and \$220.0 million aggregate principal amount of 9.125% senior secured second lien notes due 2020 (the Second Lien Notes) and, together with the First Lien Notes, the Notes in a private placement (the Notes Offering). K. Hovnanian also priced its previously announced underwritten public offering of 90,000 6.00% senior exchangeable note units (or 100,000 senior exchangeable note units if the underwriters exercise their option to purchase additional senior exchangeable note units with respect to that offering in full) (the Units) in an underwritten public offering (the Units Offering). A copy of the press releases announcing the pricing of the Notes Offering and the pricing of the Units Offering are attached hereto as Exhibits 99.1 and 99.2, respectively, and are incorporated herein by reference.

The Notes Offering has not been registered under the Securities Act of 1933, as amended (the Securities Act). The Notes may not be offered or sold within the United States or to U.S. persons, except to qualified institutional buyers in reliance on the exemption from registration provided by Rule 144A and to certain persons in offshore transactions in reliance on Regulation S. You are hereby notified that sellers of the Notes may be relying on the exemption from the provisions of Section 5 of the Securities Act provided by Rule 144A. This announcement does not constitute an offer to sell or the solicitation of an offer to buy Notes or Units in any jurisdiction in which such an offer or sale would be unlawful.
