The management of First Financial Holdings, Inc. ( SCBT or First Financial ) will participate in the Keefe, Bruyette & Woods ( KBW ) Boston Bank Conference in Boston, Massachusetts on February 26-27, 2014. Robert R. Hill, Jr., Chief Executive Officer, and John C. Pollok, Senior Executive Vice President, Chief Financial Officer and Chief Operating Officer, will meet with analysts and institutional investors, and will provide the First Financial investor booklets attached as Exhibits 99.1 and 99.2. First Financial's investor presentation is scheduled to begin at 8:45 a.m. ET on Wednesday, February 26, 2014, and will be available to investors via a live webcast on KBW's website (<http://www.wsw.com/webcast/kbw18/register.aspx?conf=kbw18&page=index&url=http%3A//www.wsw.com/webcast/kbw18/>). A copy of the presentation will be made available at SCBT's website (<http://www.SCBTonline.com>) and is attached as Exhibit 99.3 to this report and incorporated herein by reference.
