**Other Events.**

On January 10, 2016, Dalian Wanda Group Co., Ltd., a Chinese private conglomerate and the controlling stockholder of AMC Entertainment Holdings, Inc. ( AMCH ) and AMCH 's wholly owned subsidiary AMC Entertainment Inc., issued a press release in which it announced that AMCH 's Q3 income was US \$14 billion and announced an AMCH fiscal 2015 year revenue estimate. As previously reported, AMCH 's revenue and net earnings for the quarter ended September 30, 2015 were US \$688.8 million and US \$12.2 million, respectively, and for the nine months ended September 30, 2015 were US \$2.2 billion and US \$62.2 million, respectively. AMCH has not released fiscal year 2015 results and does not provide estimates. AMCH will release 2015 results in February of 2016.
