(1) On March 21, 2016, the reporting person was granted an award of performance share units, which vest in the form of common stock if certain pre-established performance goals underlying the award are met over the course of a three-year period. On February 15, 2019, the Compensation Committee of the Issuer's Board of Directors determined that the performance goals had been met, resulting in the vesting of these shares.

(2) The restricted stock vests in three equal annual installments beginning on February 15, 2020.

(3) Each deferred stock unit represents the right to receive one share of common stock of the Issuer.

(4) The deferred stock units are fully vested and will be settled in shares of the Issuer's common stock either (i) on a date selected by the reporting person pursuant to the Issuer's Management Deferred Stock Unit Purchase Plan, as amended (the "Plan"), or (ii) as otherwise provided by the Plan.

(5) Each restricted stock unit represents the right to receive one share of common stock of the Issuer.

(6) The restricted stock units will be settled in shares of the Issuer's common stock on January 31, 2024, subject to vesting acceleration pursuant to the Plan.
