 Reporting person deferred 2009 performance bonus pursuant to the Long term incentive plan - bonus deferral totalled 5772.98 shares and company match totalled 1674.164. Reporting person has deferred previous bonuses. The employer match vests ratably at 33%, 33% and (1) 34% per year over a 3 year period consequently some past company matches are not vested. Special common share units vested at 12/31/09 were 57,670.55. This bonus was approved on March 1, 2010, and we have calculated this deferral using a March 1 stock price. Cash bonuses will be paid March 12, 2010.
