The purpose of this Amendment is to add this line to the Form 4 filed on November 18, 2009. This line is added to disclose that 2,367 of (1) the Common Shares acquired by the reporting person on November 16, 2009 upon exercise of the stock appreciation right were delivered or withheld as payment of the exercise price and tax liability.
