(1) This amount includes 7,337 vested performance shares granted under the PG&E Corporation 2006 Long-Term Incentive Plan (LTIP) for the performance cycle ended 12/31/14 and 13,109 restricted stock units (RSUs) granted under the PG&E Corporation 2014 LTIP. Performance shares and RSUs are payable in shares of PG&E Corporation common stock on a one-for-one basis.

(2) Includes 3,707.16 SISOPs (phantom stock) awarded pursuant to the PG&E Corporation Executive Stock Ownership Program, and reflects the acquisition of 69.45 SISOPs on 4/15/14, 67.15 SISOPs on 7/15/14, 36.24 SISOPs on 10/15/14, and 29.05 SISOPs on 1/15/15 upon conversion of dividend equivalents received on those dates. In addition, on 9/22/14, the reporting person disposed of 3,404.32 SISOPs in a transaction exempted from Section 16. SISOPs vest three years after the date of grant subject to accelerated vesting upon certain events. Unvested SISOPs are subject to forfeiture if certain stock ownership targets are not met. Vested SISOPs are automatically payable in an

equal number of shares following termination of employment.

These holdings have been trued up to conform to the RSP balance at 3/2/15, and reflect the acquisition of 123.12 shares on 4/15/14, 119.55 shares on 7/15/14, 124.88 shares on 10/15/14, and 4.50 shares on 1/15/15 due to dividend reinvestment. In addition, on 11/21/14, the reporting person disposed of approximately 12,533 shares in a transaction exempted from Section 16.
