Item 1.01 Entry into a Material Definitive Agreement.

On August 2, 2018, S&W Seed Company (the "Company") entered into a Fourth Amendment to its Contract Alfalfa Production Services Agreement, dated December 31, 2014, with Pioneer Hi-Bred International, Inc. ("Pioneer"). The Contract Alfalfa Production Services Agreement had previously expired, and the Fourth Amendment operates to revive and extend the agreement. Pursuant to the amendment, among other things, the Company will continue to produce Pioneer's GMO-traited alfalfa varieties in certain identified production fields through May 31, 2019.
