CALGARY, Alberta (Oct. 31, 2003) - TransAlta Corporation (TSX: TA; NYSE: TAC) announced today it declared a dividend of \$0.25 per share on common shares payable Jan. 1, 2004 to shareholders of record at the close of business Dec. 1, 2003.
