TORONTO, ONT. - Peace Arch Entertainment Group Inc. (AMEX and TSX: PAE), a diversified Canadian entertainment company, today announced that it has sold multiple seasons of its long-running television series Animal Miracles to Animal Planet Asia and Animal Planet Latin America. This transaction represents our second major sale of factual series programming into the international broadcast market this year, and validates our strategy of working with distribution partners in various territories throughout the world, stated Blair Reekie, President of the company's factual subsidiary.

Peace Arch's International distributor, Portfolio Entertainment of Toronto, represented the program to Discovery Channel International and delivery was undertaken by Peace Arch's Vancouver-based documentary, lifestyle and reality television division, The Eyes Project Development Corp.

A.

Rule as to Use of Form 6-K,
