(1) On July 25, 2016, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 21,585 of the 86,340 Performance Share Units granted to Mr. Luczo on August 1, 2012. The 21,585 Ordinary Shares will vest on August 1, 2016, subject to continuous service through such date.

(2) On July 25, 2016, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 11,950 of the 47,800 Performance Share Units granted to Mr. Luczo on September 9, 2014. The 11,950 Ordinary Shares will vest on September 9, 2016, subject to continuous service through such date.
