Item 5.07 Submission of Matters to a Vote of Security Holders.

On April 27, 2018, Alliqua BioMedical, Inc. (the "Company") held a special meeting of stockholders (the "Special Meeting"). At the Special Meeting, the following three proposals were submitted to a vote of the Company's stockholders:

A proposal to approve the Asset Purchase Agreement, dated January 5, 2018 (the "Asset Purchase Agreement"), providing for the sale of our advanced biologic wound care business, including the Company's Biovance and [1] Interfyl product lines and MIST Therapy and other therapeutic ultrasound products, which may be deemed to be a sale of all, or substantially all, of the Company's assets to Celularity Inc. (the "Buyer") on the terms and subject to the conditions set forth in the Asset Purchase Agreement (the "Asset Sale"), and the other transactions contemplated by the Asset Purchase Agreement (the "Asset Sale Proposal").

A proposal to approve, on an advisory, non-binding basis, certain compensation that has, will or may be paid or (2) become payable to the Company's named executive officers in connection with the asset sale (the "Advisory Proposal").

(3) A proposal to approve an adjournment of the Special Meeting, if necessary, to solicit additional proxies if there are not sufficient votes in favor of any of the foregoing proposals (the "Adjournment Proposal").

For more information about the foregoing proposals, see the Company's definitive proxy statement filed with the Securities and Exchange Commission on March 30, 2018, the relevant portions of which are incorporated herein by reference.
