The Registrant has recently been required to expend considerable time and internal resources compiling the historical financial statements to accompany its Current Report on Form 8-K relating to its merger with Hermes Acquisition Co I LLC in 2005 and in arranging for these to be audited and filed. Although the audits were completed and all required financial statements were filed on December 19, 2005, this task took longer than originally anticipated and this has caused a corresponding delay in the completion of the Registrant's Quarterly Report on Form 10-Q for the fiscal period ended November 26, 2005. As a result, the Registrant is unable timely to file its Quarterly Report on Form 10-Q for the fiscal period ended November 26, 2005 without unreasonable effort or expense. The Registrant intends to file such Quarterly Report on Form 10-Q within the prescribed period allowed by Rule 12-25 promulgated under the Securities Exchange Act of 1934, as amended.
