RENN is the investment adviser to RENN and R US. Mr. Cleveland is the President and Chief Executive Officer of RENN. As of February 14, 2006, BFS was the owner of record and beneficial owner of 801,813 shares of the common stock of Precis, Inc. ("Common Stock") and R US was the owner of record and beneficial owner of 800,000 shares of Common Stock.

Each of BFS and R US share voting and dispositive power over their respective shares with RENN. Mr. Cleveland may be deemed to be the beneficial owner of the shares of Common Stock beneficially owned by RENN.
