David Arbel will join the company on August 1, and assume his responsibility on October 1. Mr. Beker will remain with the company during the transition period to ensure a smooth transition.

Over the past 3 years, Mr. Arbel served as the Head of ZIM Ship management Directorate and was responsible for the fleet management, technical array and the logistical supply chain, supporting the fleet in Israel and worldwide.

Scailex currently operates in two major domains of activity in addition to its holding in Partner (after selling "Dynamic", a chain of retail stores and booths to Cellcom on April 1, 2010) : (1) the sole import, distribution and maintenance of Samsung mobile handset and accessories products primarily to the major cellular operators in Israel (2) management of its financial assets.
