 - (1) Disposed of pursuant to a merger agreement providing for the merger of the Issuer and UnitedGlobalCom, Inc. (the merger involving the Issuer, the "Merger") with wholly-owned subsidiaries of Liberty Global, Inc. ("LGI") in exchange for an equivalent number of shares of LGI common stock of the same series.

The number of shares represents equivalent shares based on the fair market value of the shares of the Issuer's Series A Common Stock held by a unitized stock fund under the Liberty Media Corporation ("LMC") 401(k) Savings Plan based on a report from the Plan Administrator dated May 31, 2005. The Reporting Person has an interest in the unitized fund, which holds shares of the Issuer's Series A Common Stock and short-term investments.
 - (2) The option was 100% vested.
 - (3) The option was assumed by LGI in the Merger and replaced with an option to purchase an equivalent number of shares of LGI common stock of the same series at the same exercise price.
 - (4) The option provided for vesting as to 20% of the total number of shares on each July 31, beginning July 31, 2004.
 - (5) The Reporting Person had the choice of exercising the option for either the Issuer's Series A Common Stock at an exercise price of \$33.92 or the Issuer's Series B Common Stock at an exercise price of \$37.88.
 - (6) The option provided for vesting as to 30% of the total number of shares on February 28, 2002, and 17.5% of the total number of shares on each February 28, beginning February 28, 2003.
 - (7) The option was adjusted as to exercise price and number of shares pursuant to anti-dilution rights in the non-employee director incentive plan of the Issuer in connection with the Issuer's rights offering effective August 23, 2004.
