(1) A total of 33,000 shares of common stock of iStar Financial Inc. have been sold for the account of the reporting person as follows: on May 7, 2007, 21,000 shares were sold at a price of \$47.7176 per share and on May 8, 2007, 12,000 shares were sold at a price of \$47.4559 per share. These sales were made pursuant to a Rule 10b5-1 sales plan originally adopted by the reporting person on August 24, 2005.

(2) Following the completion of these transactions, the reporting person is the beneficial owner of a total of 2,511,426 shares of common stock of iStar Financial Inc., of which 1,843,430 shares are owned directly and 667,996 shares are owned indirectly through three family trusts. In addition, the reporting person owns an aggregate of 131,397 restricted stock units that have not yet vested, representing the right to receive an equivalent number of shares of iStar common stock if and when the units vest, 27,382 of which units were granted pursuant to an award dated March 2, 2006 and 104,015 of which units were granted pursuant to an award dated January 19, 2007.
