On May 29, 2007, the Compensation Committee of the Board of Trustees of the Issuer approved the adjustment of the outstanding options issued to the Reporting Person under the Issuer's Omnibus Stock Plans, to reflect the payment of two extraordinary dividends to the Issuer's holders of its Common Shares, one extraordinary dividend worth \$.77 per Common Share and the other worth \$.54 per Common Share (collectively, the "Adjustment").
- (1) As a result of the Adjustment, the exercise price of the outstanding options granted to the Reporting Person was reduced from \$71.275 to \$70.2986.
- (2) Immediately.
- (3) As a result of the Adjustment, this is the increased number of outstanding options granted to the Reporting Person under this previous award.
