Each Performance Share Unit represents a contingent right to receive one share of ADBE common stock. The maximum number represents 200% of the target payout of 8,333 shares.

- (5) Vesting of the Performance Share Units will be 25% upon the later of the (i) first anniversary of the grant date and (ii) the certification of performance goal achievement, with the remaining Units vesting 25% annually on the second, third, and fourth anniversary of the grant date if the initial performance goals are achieved.

On January 28, 2008, Mr. Rowley inadvertently filed a Form 4 reporting that he was granted a nonqualified stock option to purchase 10,000 shares of ADBE common stock.
