(1) Reporting Person has exercised Stock Withholding Rights in connection with this option exercise, as reflected on Table I.

In addition, the shares of phantom stock become payable in common stock in one lump sum immediately upon a director's separation from service within six months following a change of control (as defined in the Plan).

(3) Reflects additional phantom stock units received by the Reporting Person upon conversion of dividend equivalents from December 31, 2009 to the present.

(4) Of the shares being reported, 12,500 shares are subject to certain restrictions (including possible forfeiture) applicable to restricted stock grants under the 2000 Stock Incentive Plan, the 2009 Long-Term Incentive Plan, and the Restricted Stock Award Agreements.
