Each restricted stock award represents a contingent right to receive one share of the issuer's common stock. The restricted stock awards vest as to 906 shares on each of March 27, 2020, 2021, 2022, and as to 905 shares on March 27, 2023.

- (2) On July 30, 2014, the reporting person was granted an option to purchase 10,000 shares of common stock. The option vests in annual installments based on the issuer's satisfaction of certain performance criteria for each of the fiscal years ending January 31, 2016 (10%), 2017 (20%), 2018 (30%) and 2019 (40%). The performance criteria for 2019 were met, resulting in the vesting of the option as to 0,000 shares.
- (3) The option is immediately exercisable.

- (4) On September 4, 2014, the reporting person was granted an option to purchase 33,000 shares of common stock. The option vests in annual installments based on the issuer's satisfaction of certain performance criteria for each of the fiscal years ending January 31, 2016 (10%), 2017 (20%), 2018 (30%) and 2019 (40%). The performance criteria for 2019 were met, resulting in the vesting of the option as to 13,200 shares.
