Item 1.01 Entry into a Material Definitive Agreement.

On September 15, 2015, NewStar Financial, Inc. (the Company) completed a \$397.8 million term debt securitization. The notes offered in the collateralized loan obligation (the Notes) were issued by NewStar Commercial Loan Funding 2015-2 LLC, a subsidiary of the Company (NCLF), and are backed by a diversified portfolio of commercial loans originated and serviced by the Company. Investors purchased approximately \$327.8 million of the asset-backed Notes, representing approximately 82% of the value of the collateral pool. The Company retained a portion of the Class E Notes and all of the equity which totaled approximately \$70.1 million, representing approximately 18% of the value of the collateral pool. Excluding the fixed rate A-2 Notes, the blended pricing of the variable rate Notes was LIBOR plus 2.68% at closing. The reinvestment period is expected to end in August 2019 and the Notes are expected to mature in August 2027.

1 Class A-2 Notes will accrue interest at a fixed rate of 3.461%.

In connection with the completion of the term debt securitization, the Company, as transferor, entered into a Master Loan Sale Agreement, dated as of September 15, 2015 with NCLF as issuer and NewStar Commercial Loan Depositor 2015-2 LLC, a newly formed subsidiary of the Company, as retention holder. The Company, as collateral manager, also entered into a Collateral Management Agreement dated as of September 15, 2015, with NCLF as Issuer. In addition, NCLF entered into an Indenture, dated as of September 15, 2015, with U.S. Bank National Association as trustee. The Master Loan Sale Agreement, the Collateral Management Agreement, and the Indenture require the Company and NCLF to comply with various covenants and contain events of default and collateral manager termination events, which are subject to certain materiality thresholds and grace and cure periods, customary for securitizations of this type. The Master Loan Sale Agreement, the Collateral Management Agreement, and the Indenture are filed with this report as Exhibits 10.1, 10.2, and 4.1, respectively, and the foregoing descriptions of these documents do not purport to be complete and are qualified in their entirety by the full text set forth in those exhibits, which are incorporated herein by this reference. On September 21, 2015, the Company issued a press release announcing the completion of the term debt securitization. The press release is attached hereto as Exhibit 99.1 and incorporated herein by reference.

Within the United States the Notes were only sold to qualified institutional buyers in reliance on Rule 144A under the Securities Act of 1933, as amended (the Securities Act). The Notes have not been registered under the Securities Act or any state securities laws, and, unless so registered, the Notes may not be offered or sold in the United States or to
