- (1) Pursuant to Echelon Corporation 1997 Stock Plan (the "Plan"), the Reporting Person was granted a stock appreciation right with respect to 35,000 shares of Common Stock. 1/2 of such shares becomes exercisable on each of December 17, 2009 and December 17, 2010.
- (2) The Reporting Person agreed to cancellation of a stock option granted to her on August 15, 2005, in exchange for a stock appreciation right granted under the Plan having a lower per share exercise price.
- (3) Cancellation of a stock option granted to Reporting Person under the Plan on August 15, 2005 to buy 35,000 shares of Common Stock. The option was exercisable as to 1/4th of the shares on August 15, 2006 and each one year anniversary thereafter.
