- (3) This Form 4/A is being filed to correct an erroneous initial filing as Mr. Burrus actually acquired 1447.3884 shares of phantom stock, instead of the previously reported 1,271.9298 shares. The number of derivative securities owned in Column 9 has also been updated to reflect the total number of shares of phantom stock owned by Mr. Burrus on 2/6/2009. As of 8/11/2011, Mr. Burrus owns 34,407.5316 shares of phantom stock.
