Unilever NV announces that on 10 April 2008 it purchased 350,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.220 and euro 21.540 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 1,785 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 152,125,862 Unilever NV ordinary shares in treasury, and has 1,562,601,838 Unilever NV ordinary shares in issue (excluding treasury shares).
