On December 2, 1996, Microsoft Corporation ( Microsoft ) filed a Registration Statement on Form S-3, SEC 1933 Act Number 333-17143 (the Registration Statement ), which was subsequently amended on December 13, 1996 and December 16, 1996, to cover \$862,500,000 of Microsoft's 2 3/4% Convertible Exchangeable Principal-Protected Series A Preferred Shares (the Series A Shares ).

The Registration Statement was filed in order to register the Series A Shares, which were exchangeable, in certain defined circumstances, into convertible notes and/or shares of Microsoft Common Stock.

As all Series A Shares were converted to Microsoft Common Stock on December 15, 1999, Microsoft hereby de-registers all of its Series A Shares registered pursuant to the Registration Statement.
