**POST-EFFECTIVE AMENDMENT NO. 1**

Yellow Roadway Corporation (the Registrant ) is filing this post-effective amendment to the Yellow Corporation Directors' Stock Compensation Plan, as amended, Registration Statement No. 333-49618, filed on November 9, 2000 with the Securities and Exchange Commission to deregister 20,000 shares of Common Stock previously registered on Registration Statement No. 333-49618.
