Item 2.03. Creation of Direct Financial Obligation or an Obligation under an Off-Balance Sheet Arrangement of a Registrant.

On November 30, 2005, SYNEX Canada Limited (SYNEX Canada), a subsidiary of SYNEX Corporation (the Registrant), entered into a one-year revolving accounts receivable securitization program in Canada, which provides for the sale of up to C\$100 million of Canadian and United States trade accounts receivable to a Canadian chartered bank (the Bank). The program expires in November 2006, but may be renewed annually. Under this program, SYNEX Canada will sell its Canadian and United States trade accounts receivable to the Bank on a fully serviced basis. The effective purchase discount rate from time to time under the program is the prevailing bankers' acceptance rate of return or prime rate, plus 0.45% per annum. SYNEX Canada will continue to service the accounts receivable. The program also contains customary financial covenants.

In connection with this program, the Registrant issued a guarantee of SYNEX Canada's performance of its obligations under the program.
