**Item 7.01. Regulation FD Disclosure**

Tempur-Pedic International Inc. (the Company) has recently communicated a product update to its U.S. retail accounts. In the communication, the Company noted it has been experiencing spot shortages of certain mattress models due to strong consumer demand. The Company also noted its Virginia manufacturing facility is running at full capacity and that its new manufacturing facility in New Mexico is operational. The ramp-up to date of the New Mexico facility has been relatively smooth, and the Company has substantially accelerated the New Mexico production schedule to help build inventory and eliminate backorders. The Company currently anticipates continued spot shortages for several weeks.
