**Item 2.02 Results of Operations and Financial Condition**

**May 4, 2010** Clearwater, Florida - Nicholas Financial, Inc. (NASDAQ: NICK) announced that for the three months ended March 31, 2010, net earnings, excluding change in fair value of interest rate swaps, increased 52% to \$3,113,000 as compared to \$2,048,000 for the three months ended March 31, 2009. Per share diluted net earnings, excluding change in fair value of interest rate swaps, increased 44% to \$0.26 as compared to \$0.18 for the three months ended March 31, 2009. **See reconciliations of the Non-GAAP measures on page 2 of Exhibit #99.1.** Revenue increased 8% to \$14,256,000 for the three months ended March 31, 2010 as compared to \$13,224,000 for the three months ended March 31, 2009.
