Seymour is the President of each of SST and SSCIIM and owns a majority of the interests in SST. Kenneth owns a majority of the interests in SSCIIM. An agreement among SST, SSCIIM, Seymour and Kenneth in writing to file this statement on behalf of each of them is attached as Exhibit A hereto.
