Dear APFA Board of Directors, National Officers, and Negotiating Committee,

As you know, today American announced some exciting news that will begin the next chapter in the history of our great airline. We have agreed to join forces with our colleagues at US Airways to form the world's largest airline and a premier global carrier.

I think you will agree there are many benefits to this combination – an enhanced network and a path to sustainable profitability being among them. Creating this new American will better serve our customers, helping us to effectively compete and win against industry peers, and allowing us to continue to invest in our products and people.

The merger process is a significant undertaking, and as you can imagine, will take some time and coordination for us to complete successfully. For now, our flight attendants will continue to operate under the new Collective Bargaining Agreement (CBA). That will continue until we secure the necessary government and US Airways stockholder approval of the merger and Bankruptcy Court approval of our Plan of Reorganization, which will likely be in the third quarter of this year.

We are pleased that at that point in time we will be able to immediately share some of the anticipated benefits of the merger with our flight attendants as they move to the Conditional Labor Agreement (CLA) reached with US Airways last spring, as modified by the Memorandum of Understanding. In the meantime, we will continue to work closely together, as we develop the most sensible way to make the switch from the CBA to the CLA and to implement the new terms when the time comes.

This merger represents what I hope will be a bright future for our company and our flight attendants. I look forward to continuing to work with you as we begin the transition toward a stronger American, and I thank you for your commitment to taking care of the interests of our flight attendants through this unprecedented time.
