Application will be made to list the Depositary Shares on the New York Stock Exchange (the NYSE ) under the symbol RFPPrB. If approved for listing, trading of the Depositary Shares on the NYSE is expected to commence within a 30-day period after the original issuance date of the Depositary Shares.
