Hsinchu, Taiwan, R.O.C. June 24, 2014 TSMC (NYSE: TSM) today held its annual shareholders meeting, which passed the following major resolutions:

1. Approved the 2013 Business Report and Financial Statements. Consolidated revenue for 2013 totaled approximately NT\$597.02 billion and net income was approximately NT\$188.15 billion, with earnings per share of NT\$7.26.
