HCP is the general partner of HCPF. Mr. Manko is the managing member of both HCM and HCP. HCPF owns directly 2,304,626 shares of common stock and pursuant to a Warrant issued August 11, 2014 a right to immediately acquire 1,000,000 (subject to adjustment as set forth in the Warrant) shares of common stock at an exercise price of \$0.45 (subject to adjustment as set forth in the Warrant) per share. By reason of the provisions of Rule 13d-3 of the Act, each of the Reporting Persons may be deemed to beneficially own 3,304,626 shares of the Issuer's common stock. Each of the Reporting Persons disclaims beneficial ownership of any of the securities covered by this statement.
