<b>Issuer</b>	<b>Autocallable Market-Linked Step Up Notes Linked to the Worst of Two Energy Sector Stocks</b> Bank of America Corporation ( BAC )
<b>Principal Amount</b>	\$10.00 per unit
<b>Term</b>	Approximately three years, if not called
<b>Market Measure</b>	The common stocks of Schlumberger Limited (NYSE symbol: SLB ) and Exxon Mobil Corporation (NYSE symbol: XOM ) (each, an Underlying Stock )
<b>Automatic Call</b>	The notes will be called automatically on any Observation Date if the closing price of <b>each</b> Underlying Stock is equal to or greater than its Call Level
<b>Call Levels</b>	With respect to each Underlying Stock, 100% of its Starting Value
<b>Observation Dates</b>	Approximately one year and two years from the pricing date
<b>Call Amounts</b>	\$12.00 per unit if called on the first Observation Date and \$14.00 per unit if called on the second Observation Date
<b>Payout Profile at Maturity</b>	If the price of the Worst Performing Stock is flat or increases up to its Step Up Value, a return equal to the Step Up Payment  If the price of the Worst Performing Stock increases above its Step Up Value, a return equal to the percentage increase in the price of the Worst Performing Stock
<b>Worst Performing Stock</b>	1-to-1 downside exposure to decreases in the price of the Worst Performing Stock, with up to 100% of your principal at risk
<b>Step Up Values</b>	The Underlying Stock with the lowest percentage change from its Starting Value to its Ending Value
<b>Step Up Payment</b>	With respect to each Underlying Stock, [125% to 131%] of its Starting Value, to be determined on the pricing date [\$2.50 to \$3.10] per unit, a [25% to 31%] return over the principal amount, to be determined on the pricing date
