This Amendment No. 2 to Schedule 13G filed with the SEC on September 12, 2014 (as amended by Amendment No. 1 thereto filed on February 5, 2015) is being filed on behalf of BlueMountain Capital Management, LLC ( **BMCM** or the **Reporting Person** ), with respect to the shares of Common Stock, \$0.01 par value per share (the **Common Stock** ), of Scorpio Bulkers Inc., a corporation formed under the laws of the Republic of the Marshall Islands (the **Issuer** ).

- (iv) BlueMountain Monteners Master Fund SCA SICAV-SIF, an investment company with variable capital organized as a specialized investment fund in the form of a corporate partnership limited by shares under the laws of Luxembourg, with respect to the 768,751 shares of Common Stock directly owned by it;

- (v) BlueMountain Kicking Horse Fund L.P., a Cayman Islands exempted limited partnership, with respect to the 179,469 shares of Common Stock directly owned by it;
- (vi) BlueMountain Long/Short Credit Master Fund L.P., a Cayman Islands exempted limited partnership, with respect to the 807,722 shares of Common Stock directly owned by it;
- (vii) BlueMountain Strategic Credit Master Fund L.P., a Cayman Islands exempted limited partnership, with respect to the 283,149 shares of Common Stock directly owned by it; and
- (viii) BlueMountain Timberline Ltd., a Cayman Islands exempted limited company, with respect to the 354,264 shares of Common Stock directly owned by it.
