Each of the Reporting Persons hereby expressly disclaims beneficial ownership of the securities reported herein, other than to the extent of its pecuniary interest therein, and this Schedule 13D shall not be deemed to be an admission that any such Reporting Person is the beneficial owner of the securities reported herein for purposes of the Securities Exchange Act of 1934 or for any other purpose.

### Item 3. Source and Amount of Funds or Other Consideration

Item 3 is hereby supplemented as follows:

PDP acquired 260,825 shares of Common Stock in open market transactions for an aggregate purchase price of approximately \$1,550,000 using working capital.

### Item 5. Interest in Securities of the Issuer

Item 5 is hereby amended and restated as follows:

(a) As of November 17, 2017, the Reporting Persons may be deemed to beneficially own 2,053,569 shares of Common Stock (which represents approximately 5.9% of the outstanding Common Stock based upon information contained in the Issuer's Form 10-Q for the period ended September 30, 2017).
