On April 11, 2019, Anadarko Petroleum Corporation (Anadarko) entered into an agreement and plan of merger (the Merger Agreement) by and among Anadarko, Chevron Corporation (Chevron), Justify Merger Sub 1 Inc., a wholly owned subsidiary of Chevron, and Justify Merger Sub 2 Inc., a wholly owned subsidiary of Chevron. Chevron issued a press release and an investor presentation, each dated April 12, 2019, relating to entry into the Merger Agreement and related matters. A copy of the press release is attached as Exhibit 99.1 hereto and is incorporated herein by reference. A copy of the investor presentation is attached as Exhibit 99.2 hereto and is incorporated herein by reference.
