If certain operating performance goals relating to the company are met, then the RSUs will vest at the end of a three year period provided that the reporting person is still employed by the company and the company's common stock has achieved certain market performance tests. The operating performance goals and market performance tests have been established by the Compensation Committee of the Board of Directors of the Company. Vested shares will be delivered to the reporting person at such time unless the reporting person has elected to defer receipt.
- (3) Represents the target number of shares included in the RSUs. The actual number may increase 50% or decrease 25% based upon actual company performance against the established operating performance goals.
